Our Taxes:

**In March you will be billed from the County and Colerain Township, or better known as The Spring Taxes**

To calculate your tax, multiply your assessed value times the amounts for each entity.

I have used \$ 100,000.00 as an example.

Lancaster County Tax Mil is 2.911 \$ 100,000.00 x .002911 = \$ 291.10

Colerain Township Municipal Tax Mil is .518 \$ 100,000.00 x .000518 = \$ 51.80

Colerain Township Per Capita Tax- This is a head tax at \$ 10.00 per persons 18 years of age to 80 years of age that are not disabled.

**In June you will be billed from the Solanco School District for Property Tax or better known as The Fall Taxes**

Solanco School District Tax Mills are 10.9604 \$ 100,000.00 x .0109604 = \$ 1,096.04

So, total Real Estate Tax with County, School and Municipal is 14.39 Mills or .01588 plus Per Capita

**\*Please note the amount of zeroes in front of each number before you multiply.**

PA State Sales Tax is 6%.

PA State Income Tax rate is 3.07%

Solanco School District Local Tax is 1.65%

**PA State Police-Colerain Township does not have a Police Dept. If you have a routine question that is not an emergency they can be reached at 717-299-7650**

**Ambulance: We are served by Lancaster Emergency Management Services Ambulance (LEMSA) and Oxford Ambulance Companies. Colerain Township does not have its own Ambulance Assoc.**

**Fire Co: We are served by Quarryville Fire Co and Bart Fire Co. Colerain does not have its own Fire Company.**
